## LINE MECHANIC COMPETITION RULES, TERMS AND CONDITIONS

#### Rules of Eligibility

To compete in this competition, you must have a team of four.

- Three of the team members must be New Zealand registered line mechanics with current practicing licenses.
- The fourth team member must be a trainee line mechanic on an approved New Zealand line mechanic pathway.
- If the team or team members are from outside of New Zealand and do not hold New Zealand qualifications and practicing licenses, then the organising committee (at its sole discretion) will consider and approve entry based on the following criteria;
  - 1. Line Mechanics must provide evidence that they hold the New Zealand equivalent qualifications as registered Line Mechanics and/or hold New Zealand equivalent practicing licenses in their local jurisdiction and;
  - 2. They hold a current competency in CPR/First Aid and Pole Top Rescue procedures and;
  - 3. They have current competency at operating crane trucks and;
  - 4. They can provide recen't evidence of their testing for safety procedures used in completion of the work.

New Zealand Trainee line mechanics that completed their last block course prior to the competition may still compete as TLM providing, they are still registered with the Electrical Workers Registration Board on the limited learner's license.

International Trainee Line Mechanics will need to provide evidence to satisfy the organising committee (at their sole discretion) that they are on a similar approved pathway to completing Line Mechanic qualifications in their local jurisdiction.

#### Other Key Criteria

All competitors acknowledge in entering that they will need to be familiar with and comply with the NZ Electricity Industry Safety Rules as published by the NZ Electricity Engineers Association (EEA) and other relevant NZ Codes of Practice.

#### **Events**

Each team will participate in all events contained in the program.

#### 2 Competitor Registration

Competitor registration will be held on Monday 21 October 2024. Time and Venue TBC

The team managers of any teams/competitors who are unable to attend registration at this time must advise the Event Manager Hillary Riches, hillaryr@connexis.org.nz as

soon as possible, but no later than **Thursday 17 October 2024.** Unforeseen circumstances will be accepted.

Withdrawals from the competition must be by written notification and emailed to the Event Manager Hillary Riches, hillaryr@connexis.org.nz no later than **1 October 2024.**Competition withdrawals received after this date may be subject to a request to cover associated competition costs incurred by Connexis.

#### Judging Guidelines

Industry experts who have experience in line mechanic examinations and competitions have been selected to judge the events and will follow strict criteria. The first aid event will be judged by a recognised First Aid trainer or St John.

Judging will be based on best industry practices and procedures used across New Zealand and industry guides, regulations, and handbooks.

One Chief Judge will oversee and, if necessary, moderate the individual Event Judges to ensure fair and consistent judging across all teams.

There will be a minimum of one judge per team for each of the events.

Competitors can only ask questions of the Event Judges before the individual event begins, after the specification sheet is handed to the teams during the tailgate session, but not during the event.

Please Note: The new SMEI format will be used from 2022

#### 5. Scoring

Team members may be judged as individuals or pairs. However, it is the teams' average score for each event that contributes to their overall score.

Points will be deducted for any infringements as identified on the score sheet.

Where teams are tied, time may be the determining factor. The Chief Judge and Competition Manager may use their discretion to decide on the additional criteria used to determine the results if no other factors from the event judging sheets can separate the winner.

The Competition Manager and the Chief Judge decision will be final, and no correspondence will be entered into. Additional penalty points will be deducted from teams for the following infringements.

Where teams are tied, time may be the determining factor. The Chief Judge and Competition Manager may use their discretion to decide on the additional criteria used to determine the results if no other factors from the event judging sheets can separate the winner. The Competition Manager and the Chief Judge decision will be final, and no correspondence will be entered into. Additional penalty points will be deducted from teams for the following infringements.

#### **Two Penalty Points:**

- Not wearing appropriate personal protective equipment (PPE)
- Dropping of tools/equipment
- Misuse of tools/equipment
- Knife blade unprotected
- Pole strap dragging on ground
- Untidy work site
- Tape on harness

#### **LINE MECHANIC COMPETITION**

#### RULES, TERMS AND CONDITIONS

#### 5. Five Penalty Points:

- Not being attached at all times
- Ladder not secured before climbing
- Carrying equipment in hands while climbing ladder
- Not using hand line to raise and lower equipment
- Not wearing insulting gloves ground to ground
- Faulty equipment
- Tools, equipment, or vehicles out of test

**Note:** The penalty points listed above are not exhaustive and the judges will use their experience and industry best practice to identify further potential infringements. Points may also be deducted for improper procedures or safety violations not listed.

Teams may be disqualified for unprofessional behavior. An Event Judge, Chief Judge or the Competition Manager may disqualify a competitorwho appears to be under the influence of alcohol or drugs. The team manager can challenge the disqualification by requesting a breath screening test or drug screen, which will be carried out by a suitably qualified independent person at no cost to the competitor's company.

#### **Alcohol Breath Screening Test**

Testing will be carried out using a breathalyser or digital alcohol meter that complies with AS 3547:1997

If the team member is over 18 years of age and the reading is:

- 250 micrograms of alcohol per litre of breath or less, the competitor will continue in the competition.
- More than 400 micrograms per litre of breath, the original decision to disqualify the competitor will be upheld.

There is zero alcohol limit for competitors 18 years of age or under

#### Drug Screen

Drug screening will be in compliance with AS/NZS 4308:2008. If the result is:

- Negative the team will continue in the competition.
- No-Negative the original decision to disqualify the team will be upheld.

#### Disputes

With the exception of Rule 5.5 only competitors can lodge a dispute. The levels of authority for any dispute or disciplinary action are as follows:

- Team Member
- Team leader
- Event Judge
- Chief Judge and Competition Manager. Any decision made at this level will be final.

#### Health & Safety

It is the responsibility of companies to ensure their employees are not under the influence of alcohol or drugs during the event.

All competitors and team managers must attend the following briefings, which will be held at the competition venue (Times may be subject to change)

- 22 October at 7am
- 23 October at 7am
- 24 October at 7am

Before beginning an event, each team must complete a tailgate and put in place the control methods identified on the tailgate.

All competitors must wear PPE and use tools and equipment that are appropriate for each task.

All accidents/incidents must be reported to the Competition Manager.

#### **N** Tools, Equipment, vehicles and PPE

Competitors must use a full-body harness that complies with AS/NZS 1891.4:2009. Lower body harness/safety belts (i.e., traditional line mechanic belts) will not be permitted.

It is the responsibility of competitors to ensure their PPE, tools, vehicles and equipment are safe, currently "in test" and appropriate for the tasks they will have to carry out during the competition.

Any equipment found to be faulty or out of test will be removed and the team will incur penalties. Competitors should ensure they have copies of test certificates available as judges may request evidence for relevant equipment.

#### WEATHER

In the event of extreme or arduous weather conditions like lightning, high winds or heavy continuous rain, a decision to cancel, delay, postpone or proceed will be made by the competition manager.

#### 10. COMPETITION AWARDS PRESENTATION AND INDUSTRY EXCELLENCE AWARDS DINNER

The Competition Awards presentation and excellence Awards Dinner will be held on the final day of the competition, 24 October 2024, at 6.00pm. Tickets are required to attend this event and can be purchased from the Event Manager prior to the evening.

All teams are expected to attend this event. There will be no announcement of the top three competitors at the competition.

Connexis as the event owner will be enforcing host responsibility. Competitors and guests who are visibly intoxicated will be asked to leave the premises and will not receive a refund of their ticket price.

#### 11. FILMING AND PHOTOS OF COMPETITION EVENTS

Competition Chief Judges and Connexis Event Management will have the discretion to ask competitors or associated support people to refrain from taking photos/videos in or around the competition arenas that is deemed to be at the disadvantage of other competitors.

The competition has official photographers (Still & Video- Aerial Drone) and no other photographers will be allowed into the competition arena. The flying of drones inside the arena and outside the arena within a distance of 10m from the arena fencing is strictly prohibited.

#### 12. COVID-19

Connexis, is committed to COVID-19 Ministry of Health guidance and will take responsibility to stay up to date regularly and consistently with Ministry of Health guidance prior to and during the event.

The event management plan will be circulated to all competitors prior to the event outlining all details around Covid and other health & safety policies related to the event.



## **CABLE JOINTER COMPETITION**RULES, TERMS AND CONDITIONS

#### 1 | RULES OF ELIGIBILITY

To compete in this competition, you must be:

- New Zealand registered Cable Jointer with current practicing licenses.
- If the Cable Jointer is from outside of New Zealand and does not hold New Zealand qualification and practicing license, then the organising Committee (at its sole discretion) will consider and approve entry based on the following criteria:
  - o Cable Jointer must provide evidence that they hold the New Zealand equivalent qualifications as NZQA/EWRB registered Cable Jointer and/or hold New Zealand equivalent practicing license in their local jurisdiction and:
  - o They hold current competency in CPR/First Aid procedures and:
  - They can provide evidence of recent Live LV jointing and HV jointing experience and:
  - They can provide recent evidence of their testing for safety procedures used in completion of the work.

Trainee Cable Jointers may be approved to enter the competition provided the organising Committee is satisfied (at its sole discretion) that the Trainee is far enough along on his pathway and sufficient knowledge, skills and experience to be able to complete the expected tasks in the competition competently and safely.

#### **Other Key Criteria**

All competitors acknowledge in entering that they will need to be familiar with and comply with the NZ Electricity Industry Safety Rules as published by the NZ Electricity Engineers Association (EEA) and other relevant NZ Codes of Practice.

#### 9 EVENTS

Each competitor will participate in a minimum of eight events.

#### COMPETITOR REGISTRATION

Competitor registration will be held on **Monday 21 October 2024** Venue and Time TBC.

Any competitors who are unable to attend registration at this time must advise the Event Manager Hillary Riches, hillaryr@connexis.org.nz as soon as possible, but no later than **Thursday 17 October 2024.** Unforeseen circumstances will be accepted.

Withdrawals from the competition must be by written notification and emailed to the Event Manager Hillary Riches, hillaryr@connexis.org.nz no later than **1 October 2024.** Competition withdrawals received after this date may be subject to a request to cover associated competition costs incurred by Connexis.

#### JUDGING GUIDELINES

Industry experts who have experience in cable jointing and assessment have been selected to judge the events and will follow strict criteria. The first aid event will be judged by a first aid provider.

Judging will be based on best industry practices and procedures used across New Zealand and industry guides, regulations, and handbooks. These include but are not limited to:

One Event Judge may judge up to two competitors at a time.

The Chief Judge will oversee and if necessary, moderate the individual Event Judges to ensure fair and consistent judging across all competitors.

Competitors can only ask questions of the Event Judges before the individual event begins or during the tailgate session, but not during the event.

**Please Note:** The new SMEI format will be used from 2022

#### SCORING

1 (one) or 2 (two) points will be deducted for minor infringements, for example steps missed in procedures. 5 (five) points will be deducted for every critical error, for example improper procedures and safety violations. 25 (twenty-five) points will be deducted for a major critical error.

Points will be deducted for tasks not completed for each event.

A clear safety breach which in normal circumstances could result in death or injury will result in the competitor receiving 0 (zero) points for the event.

The judges may use their experience and industry best practice to identify further potential infringements.

Where competitors are tied, time may be the determining factor. The Chief Judge and Competition Manager may use their discretion to decide on the additional criteria used to determine the results if no other factors from the event judging sheets can separate the winner. The Competition Manager and the Chief Judge decision will be final, and no correspondence will be entered into.

Competitors may be disqualified for.

- Unprofessional behavior
- Receiving outside assistance after an event starts, including tailgate process

An Event Judge, Chief Judge or the Competition Manager may disqualify a competitor who appears to be under the influence of alcohol or drugs. The person designated as the company contact on the registration for can challenge the disqualification by requesting a breath screening test or drug screen, which will be carried out by a suitably qualified independent person at no cost to the competitor's company.

#### **Alcohol Breath Screening Test**

Testing will be carried out using a breathalyser or digital alcohol meter that complies with AS 3547:1997. If the competitor is over 18 years of age and the reading is:

- 250 micrograms of alcohol per litre of breath or less, the competitor will continue in the competition.
- More than 400 micrograms per litre of breath, the original decision to disqualify the competitor will be upheld.

There is zero alcohol limit for competitors 18 years of age or under.

#### **CABLE JOINTER COMPETITION**

#### RULES, TERMS AND CONDITIONS

#### 5. Drug Screen

Drug screening will be in compliance with AS/NZS 4308:2008. If the result is:

- Negative the competitor will continue in the competition.
- No-Negative the original decision to disqualify the competitor will be upheld.

#### 6. DISPUTES

With the exception of Rule 5.7 only competitors can lodge a dispute. The levels of authority for any dispute or disciplinary action are as follows:

- Event Judge
- Chief Judge and Competition Manager. Any decision made at this level will be final.

#### 7. HEALTH & SAFETY

It is the responsibility of companies to ensure their employees are not under the influence of alcohol or drugs during the event.

All competitors must attend the following briefings, which will be held outside the Cable Jointer Competition Arena (Times may be subject to change)

- 22 October 2024 at 7am
- 23 October 2024 at 7am
- 24 October 2024 at 7am

Before beginning an event, each competitor must complete a tailgate and put in place the control methods identified on the tailgate.

All competitors must wear current "in test" PPE and use tools and equipment that are appropriate for each event.

The following practices and tools are required for the LV Jointing event:

- Competitors must wear insulated rubber gloves during the entire jointing task barehand techniques will not be accepted.
- Competitors must have an "in test" rubber mat or boots.
- Earth bonds are needed.
- Current insulated tools must be used.
- Current "in test" PPE gear must be worn, including hardhats and eye protection.

In addition to wearing "in test" PPE gear, competitors must wear rubber gloves for the Testing to Ensure Safety event.

All accidents/incidents must be reported to the Competition Manager.

#### TOOLS, EQUIPMENT AND PPE

Competitors must bring with them basic test instruments, including an insulation tester, multimeter, independent earth tester, a gas bottle (with regulator and correct compression hose fittings) and gun, torque wrench and all other tools, equipment, and PPE they believe are needed for the tasks they will have to carry out during the competition.

It is the responsibility of competitors to ensure their PPE, tools and equipment are safe and currently "in test".

Competitors with faulty or out of test PPE, tools or equipment will not be allowed to

compete. Competitors should ensure they have copies of test certificates available as judges may request evidence.

#### WEATHER
